

REQUIREMENTS FOR SOLO PARENT CATEGORIES

FOR THE SOLO PARENT ON ACCOUNT OF THE DEATH OF THE SPOUSE (PARA SA NAMATAY ANG ASAWA)

- Birth certificate/s of the child or children
- Marriage Certificate
- Barangay Certificate on (if not Married)
- Death Certificate
- Affidavit of declaring that the solo parent is not cohabiting with a partner or co-parent and has no sole parental care and support of the children or child.
- Affidavit of a barangay official assessing that the solo parent is a resident of the Barangay and that the child or children is/are under the parental care and support of the solo parent.

FOR THE SOLO PARENT ON ACCOUNT OF THE DETENTION OR CRIMINAL CONVICTION OF THE SPOUSE (PARA SA NAKAKULONG ANG ASAWA)

- Birth certificate/s of the child or children
- Marriage Certificate
- Barangay Certificate on (if not Married)
- Certificate of detention or certificate on that the spouse is serving a sentence for at least three(3) months
- Affidavit of declaring that the solo parent is not cohabiting with a partner or co-parent and has no sole parental care and support of the children or child.
- Affidavit of a barangay official assessing that the solo parent is a resident of the Barangay and that the child or children is/are under the parental care and support of the solo parent.

FOR THE SPOUSE OF OFW (PARA SA NASA ABROAD ANG ASAWA)

- Birth certificate/s of the child or children
- Marriage Certificate
- Barangay Certificate on (if not Married)
- Philippine Overseas Employment Administration Standard Employment
- Photo copy of passport
- Proof of income of the OFW's spouse
- Photo copy of OFW's Contract
- Affidavit of declaring that the solo parent is not cohabiting with a partner or co-parent and has no sole parental care and support of the children or child.
- Affidavit of a barangay official assessing that the solo parent is a resident of the Barangay and that the child or children is/are under the parental care and support of the solo parent.



FOR THE SOLO PARENT ON ACCOUNT OF ABANDONMENT BY THE SPOUSE (PARA SA INIWANAN NG ASAWA)

- **Birth certificate/s of the child or children**
- **Marriage Certificate**
- **Barangay Certification (if not Married)**
- **Affidavit of declaring that the solo parent is not cohabiting with a partner or co-parent and has no sole parental care and support of the children or child.**
- **Affidavit of a barangay official assessing that the solo parent is a resident of the Barangay and that the child or children is/are under the parental care and support of the solo parent.**

FOR THE SOLO PARENT WHO IS A LEGAL GUARDIAN, ADOPTIVE OR FOSTER PARENT

- **Birth certificate/s of the child or children**
- **Proof of guardianship, such as the decision granting legal guardianship**
- **Authorization of the parent of children or child.**
- **Affidavit of declaring that the solo parent is not cohabiting with a partner or co-parent and has no sole parental care and support of the children or child.**
- **Affidavit of a barangay official assessing that the solo parent is a resident of the Barangay and that the child or children is/are under the parental care and support of the solo parent.**
