CONTRACT AGREEMENT

THIS AGREEMENT, made this 29th day of January, 2025 between Municipality of Rizal, Nueva Ecija with principal office at Aglipay St., Brgy. Pob. Sur, Rizal, Nueva Ecija represented by Hon. HANNA KATRINA L. ANDRES, Municipal Mayor who is duly authorized to represent LGU- Rizal, Nueva Ecija in this contract (hereinafter called the "Entity")

and

FC MARTINEZ CONST. DEV'T & SUPPLY CORP. with principal office at #24 Rizal St., Brgy. Calaocan, San Jose City, Nueva Ecija, represented by MR. JAFER MARCON E. MARTINEZ, in his capacity as Authorized Managing Officer, (hereinafter called the "Contractor").

WHEREAS, the LGU-RIZAL is in need of a Contractor that will perform for the project INSTALLATION OF SOLAR STREET LIGHTS (110 UNITS) located at B-gy. Aglipay to Brgy. Bicos, Rizal, Nueva Ecija (hereinafter called "the Works") and the Entity has accepted the offer of FC MARTINEZ CONST. DEV'T & SUPPLY CORP thru Contract Agreement amounting to EIGHT MILLION SEVEN HUNDRED NINETY ONE THOUSAND THREE HUNDRED FOURTEEN PESOS AND 63/100 (Php 8,791,314.63) for the execution and completion of such as stipulated in the Program of Works and remedying any defects thereon.



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
 - a) The Contractor agrees to perform well faithfully to furnish all of the equipment, materials, supplies, labor and superintendence and other facilities requisite for incidental to the successful completion of the Works and the carrying out of all the duties and obligations imposed by the Contract Documents.
 - b) The Contractor agrees to satisfactorily complete all of the Contract Works under this Contract within for one hundred fifty (150) working days from receipt of the Notice to Proceed.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
- a. Philippine Bidding Documents (PBDs);
 - Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - General and Special Conditions of Contract; iv.
 - Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted.









Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of <u>EIGHT MILLION SEVEN HUNDRED NINETY ONE THOUSAND THREE HUNDRED FOURTEEN PESOS AND 63/100 (Php 8,791,314.63)</u> or such other sums as may be ascertained, FC MARTINEZ CONST. DEV'T & SUPPLY CORP. agrees to INSTALLATION OF SOLAR STREET LIGHTS (110 UNITS) located at Brgy. Aglipay to Brgy. Bicos, Rizal, Nueva Ecija in accordance with his/her/its Bid.
- 4. The LGU-RIZAL agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
